NOTE: Proof of identification (photo ID and proof of social security number) will be required for all winning tickets for more than \$600.

2. Complete only the "Claimant" section of this form. Only one character per box.
3. Sign and date this form.
4. Attach the winning ticket to this form.
5. Mail or hand deliver this claim form and the winning ticket to one of our claim centers.
6. If you send by mail, keep a copy of the ticket and claim for your records.
Registered mail is recommended for your protection. Include readable copy of your driver's license or state ID for all mail requests for payment.
