GAME PROMOTION PROCEDURES**

Instant Game

Promotion

Purchase a \$2 Bass Pro Shops scratcher ticket and any non-winning Bass Pro Shops scratcher ticket (“winning tickets” include any ticket that awards a free ticket as a prize) may be submitted as an entry into the Bass Pro Shops Second Chance promotion to win the prize listed below.

Promotion Dates

August 30- October 31, 2011

Drawing Dates

October 3 and November 1, 2011

Prizes

1. Two hundred (200) \$50 Bass Pro Shops Giftcards

Each winner will be awarded one (1) \$50 Gift card to Bass Pro Shops; 100 giftcards will be awarded for each separate drawing.

Entry Submission Methods

1. Oklahoma Lottery Website- Players may enter the promotion via the Oklahoma Lottery website, www.lottery.ok.gov. To enter, players must submit all of their contact information and the required codes from the entry ticket on the designated promotion webpage. Players must save their original scratcher ticket once it has been entered online. When entering online, players may be required to present the original entry ticket to complete the validation process if selected as a winner. If you enter online and cannot produce the ticket if you are selected as a potential winner, you will be disqualified.
2. Postal Mail - An official entry consists of an eligible non-winning scratcher ticket with contact information completed and mailed to the Oklahoma Lottery headquarters. A complete name, address, telephone number, email (optional), signature and checked age verification box must be provided on the entry. Entries must be submitted in an envelope. Multiple entries in an envelope will be accepted. Each entry will be valid throughout the duration of the promotion. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail. Valid entries must be received in the offices of the Oklahoma Lottery by end of day on the final day of the entry period to be included in the selection process.

3. Entries must be submitted by the end of day on the final day of the entry deadline to be eligible for the drawing.

Drawing Information

1. Drawing Details

The Prize Drawings will be held at the Oklahoma Lottery headquarters. During the drawings, access to the mailroom will be limited and a log will be maintained of all OLC employees present for each drawing and their roles. Only the promotions manager, security official, IT representative and the internal auditor should be present during the drawing. Entries from both the Oklahoma Lottery website and the postal mail entries will be prorated to determine the appropriate number of entries to select from each group for each separate drawing. The entries will be placed in a hopper for a drawing to determine prize distribution. A blindfolded lottery employee will draw the pre-determined amount of entries from the hopper to serve as both the winners and the alternates. For drawings 1 and 2, the 1st through 100th entries drawn will be awarded one (1) \$50 Bass Pro Shops Giftcard. The 101st through 150th entries drawn will serve as alternates. The official drawings will be held on the following dates: October 3 and November 1, 2011.

The promotions manager will record the drawn ticket and entrant's information for all entries. Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

General Rules and Procedures

1. All prize winners must be 18 years or older. Winners will be required to provide proof of age.
2. Winner(s) will be notified via phone/mail of their winner status using the contact information provided on the entry ticket/submission after all validation and verification has taken place.
3. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov, and at authorized OLC retailers.
4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
5. Prizes pictured in game materials and on the Lottery website are for illustrative purposes only.
6. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
7. The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. 10. The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
11. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
12. Each person entering this promotion agrees by the act of participation to be bound by these promotional procedures of the Oklahoma Lottery.
