

Power Play and Sizzler Promotion September 2008 GAME PROMOTION PROCEDURES

Purpose

The purpose of this document is to provide a clear understanding of the promotional aspects of the Power Play and Sizzler promotion. The online games components of the promotion are governed by the OLC Rules. The rules as well as these promotion procedures promote the integrity of the Oklahoma Lottery and ensure award winners are selected impartially and randomly.

Online Game – Powerball with Power Play / Hot Lotto with Sizzler

Promotion

Purchase \$5 in Power Play or Sizzler (\$10 Powerball or Hot Lotto transaction) and receive an entry to win the prize listed below.

Promotion Dates

Entries are available from September 1 - 27, 2008. Entry submission will be accepted until close of business Wednesday, October 1, 2008.

Prizes

One hundred (100) winners will be awarded the following prize.

1. One (1) year's worth of Powerball and Hot Lotto tickets.

a. <u>Prize includes:</u> Cash payment for one (1) year's worth of Powerball with Power Play tickets and one (1) year's worth or Hot Lotto with Sizzler tickets. Prize value \$416 for each winner.

\$2 Powerball with Power Play Ticket

+\$2 Hot Lotto with Sizzler Ticket

=\$4 in tickets X 52 weeks X 2 draws per week

=\$416 Cash Payment

b. <u>Fulfillment:</u> The winner's contact information will be verified after the drawing and the winner will be contacted within five (5) business days to make arrangements on prize fulfillment.

Official Entries

Entries to the Power Play and Sizzler promotion will be attained by purchasing \$5 in Power Play or Sizzler (\$10 Powerball or Hot Lotto transaction). A "trail ticket" will be printed with every \$5 Power Play or Sizzler transaction and will serve as the official entry form. Entrants should then complete the entry form and submit it to the Oklahoma Lottery. Entries can be received in the form of postal mail, hand delivery or website submission.

Entry Submission Methods

Entries for the promotion can be submitted in the following manners:

1. Postal Mail - An official entry consists of an eligible entry form printed as a trail ticket from a \$5 Power Play or Sizzler purchase (\$10 Powerball or Hot Lotto transaction) with the completed entry form, mailed to the Oklahoma Lottery headquarters in an envelope. **Multiple entries per envelope will be accepted.** Entries mailed to the Oklahoma Lottery that are not placed in an envelope will be disqualified. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail.

- 2. Oklahoma Lottery Website- Players may also enter the promotion via the Oklahoma Lottery website, <u>www.lottery.ok.gov</u>. To enter players must submit all of their contact information and the 15 digit code from their trail ticket on the designated webpage. The original trail ticket must be presented to the OLC to complete the validation process if selected as a winner. Do not enter the promotion in more than one method for each ticket, if you enter online and cannot produce the ticket if you are selected, you will be disqualified.
- 3. Deposit Entry at OLC Headquarters- Completed entries may be deposited at OLC headquarters in the claims office. Oklahoma Lottery employees cannot hand deliver entries given to them from any participating individual and any entry delivered in such manner will be disqualified.

Submission Deadlines and Requirements

- 1. Only entries received by the close of business on Wednesday, October 1, 2008, will be eligible for the drawing. The Oklahoma Lottery is not responsible for entries received after the deadline. Entries received at the address listed on the ticket (also listed above) after the entry deadline date will be deemed ineligible for the drawing and will be destroyed. An entry is only eligible for this drawing and cannot be re-entered for any future drawings. Players may enter as often as they wish using valid entries.
- 2. A complete name, address, telephone number, email (optional) and signature must be provided on the entry, so that the owners of selected entries can be identified and contacted. Incomplete or illegible entries will be disqualified. Entries with address stamps or stickers are acceptable, but they also must have a complete name, address, telephone number, email (optional) plus the entrants' signature.

Winner Selection

Once all entries have been received, one hundred (100) winners will be selected through a random drawing process. Entries from both the Oklahoma Lottery website and the postal mail/ hand delivered entries will be prorated to determine the appropriate number of entries to select from each group. Double the amount of needed winners will be selected to serve as both the winners and the alternates for the promotion. Any entry selected that does not qualify as a valid entry, according to the official promotion procedures, will be discarded. Documentation outlining the drawing procedures will be made available upon request by the Oklahoma Lottery. The official drawing will be held on Friday, October 3, 2008.

General Rules

- 1. Players will be limited to winning only once in the promotion.
- 2. If more than one person's name appears on any of the tickets drawn as a winner, these individuals will be notified, and it will be their responsibility to declare ownership of the prize.
- 3. Winner(s) will be notified via postal mail and/or phone of their winner status after all validation and verification has taken place. Winner(s) will be required to provide proof of age and identification to the Oklahoma Lottery. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov. If a winner does not meet all promotion qualifications (valid entry, age requirement, etc.) they will be disqualified and another entry will be selected and subsequently validated and verified
- 4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
- 5. Prizes pictured in game materials and on the Lottery website are for illustrative purposes only.
- 6. Only persons 18 years of age or older are eligible to enter and win. Winners will be required to furnish proof of age.
- Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
- 8. The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the Oklahoma Lottery and will not be returned. CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE OKLAHOMA LOTTERY RESERVES THE RIGHT TO CANCEL THE PROMOTION IF IT BECOMES TECHNICALLY CORRUPTED.
- 9. No other tickets or entries are eligible for this promotion, including Scratchers games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
- 10. The Oklahoma Lottery is not responsible for any non-promotional mail inadvertently sent to the promotional address.
- 11. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.

- 12. The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
- 13. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
- 14. The Oklahoma Lottery is not responsible for scratcher tickets and/or online game claims sent to the promotional mailing address for non-promotion, cash related prize payment. Tickets sent to the promotional mailing address to be cashed will be considered lost mail.
- 15. This promotion and subsequent prizes are in addition to, not substitute to any and all prizes associated with the Powerball and Hot Lotto online games.
- 16. Each person entering this promotion agrees by the act of participation to be bound by these Online Promotional Procedures of the Oklahoma Lottery.
- 17. These Online Promotional Procedures may be modified at any time at the sole discretion of the Oklahoma Lottery.
