**General Fulfillment:**

1. By accepting the prize(s) the winner agrees to all of the terms and conditions of the Oklahoma Lottery Commission (OLC). Terms and conditions can be found on the specific promotion page on the OLC website.

2. The OLC will take photos and videos of winner accepting their prize. By accepting the prize, the winner authorizes the OLC to use their image/voice in recordings and photographs to be used for promotional advertising. Failure to comply will result in forfeit of prize and an alternate winner will be chosen.
3. Winners must pick up their prize at the OLC Headquarters.
4. Winner must provide a government issued photo I.D. via email, fax or in person as proof of age to claim their prize. Any prize over the amount of \$600 will require proof of social security card.
5. Winner must be an Oklahoma resident living in the state of Oklahoma at the time of the drawing and may be asked to provide proof of residency.
6. There is no cash value in lieu of the advertised prizes.
7. Winner may forfeit the prize, in doing so that prize will be awarded to an alternate winner.
8. Winner may transfer the prize to someone else. If winner chooses to transfer the prize they must do so in writing by notarized letter stating the intent to transfer and the name of the recipient. The recipient must then complete the OLC claims process in its entirety at the OLC Headquarters.

### **Entry Submission Methods**

All active Instant tickets may be entered on the OK Lottery App or online at [www.lottery.ok.gov](http://www.lottery.ok.gov). Players can scan the barcode from the front of any active Oklahoma Lottery Scratcher and points will be deposited into their account. Players will earn the same number of points as the price point of the Scratcher ticket.

Players can select the prize drawing they wish to enter and select the (+) icon to add or the (-) icon to remove entries from that drawing. Once entries have been submitted they can no longer be removed from that prize drawing. Points will automatically be deducted from their account once entries have been submitted

### OK Lottery App

To enter, players must download the OK Lottery App to their IOS or Android mobile device and complete **ALL** registration fields (first and last name, email, birth date, phone number, address, city, zip, and password) to create a user account. By registering on the app, you agree to the terms of service and privacy policy of the app. Players must be 18 years or older to register and win the prize. Once an account is registered, players will need to confirm their email address linked with the app and verify their account. Once their account is verified, they can log in to their account.

Players may scan the barcode located on the front of their ticket. Players may also choose to manually enter their ticket by typing in the three (3) digit game number, six (6) digit pack number and three (3) digit ticket number located on the back of their ticket followed by entering in the twelve (12) digit validation number located on the front of their ticket. Players *must save* their original entry ticket once it has been scanned or manually entered on the Oklahoma Lottery App and will be required to reproduce the ticket during the validation process. *Failure to reproduce the required ticket can result in disqualification.*

### Oklahoma Lottery Website

To enter, players must create a user account with all of the required contact information and submit the required codes from the designated ticket on the promotional web page located at [www.lottery.ok.gov](http://www.lottery.ok.gov). The age verification box must also be completed providing confirmation that the entry is being submitted by a person at least 18 years of age. Players must save their original entry ticket once it has been entered online and will be required to reproduce the ticket during the validation process. Failure to reproduce the required ticket can result in disqualification.

### **Drawing Information**

The prize drawing will be held at the OLC headquarters. During the drawing, only the drawing representative, security official and an accounting representative will be present. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer-based automated drawing system will be used to execute the official drawing. A total of three (3) entries will be drawn for each promotional drawing. The first entry drawn

will be assigned the winner and will be awarded the prize, pending validation through the OLC claims process. The remaining entries drawn will be assigned as alternates in case the winner cannot claim their prize.

The winners will be contacted by the OLC for prize fulfillment purposes. If there are not enough valid entries within the total number drawn, an equal amount will be re-drawn and subsequently validated through the OLC claims process.

### **Promotion Specific Rules and Procedures**

1. Players can only win **one (1)** prize each weekly drawing and one (1) each monthly drawing.

### **General Rules and Procedures**

1. All prize winners must be 18 years or older. Winners will be required to provide proof of age. Any prize of over the amount of \$600 will require proof of social security card.
2. Winner(s) will be notified via phone of their winning status using the contact information provided on their user account. After initial contact, winner must complete the OLC validation process within **five (5) business days or winner will automatically forfeit the prize**. A reminder phone call will be initiated at the end of the 4th day notifying that winner has less than 24 hours until their prize is forfeited. Final awarding of prize will take place after all validation processes have been completed.

If a winner is not able to be reached by phone a voicemail (if possible) will be left, email and written letter will be sent indicating that the winner has five (5) business days to contact the OLC or the prize will be forfeited. Once the winner contacts the OLC, then they will have an additional five (5) days to complete the OLC validation process. A reminder phone call will be initiated at the end of the fourth (4<sup>th</sup>) day notifying the winner that they have less than 24 hours until their prize is forfeited. Final awarding of prize will take place after all validation processes have been completed.

If a prize has a time sensitive element to it (i.e., event or sporting tickets), the Lottery may decrease the contact deadline or validation deadline to a period not less than 24 hours.

Any other variation to the communicated deadline must have an approval by the Director of Marketing and Administration.

3. By submitting an entry, each player authorizes the OLC to release prize winner information to various media sources. Winners' names and pictures will also be posted on the Oklahoma Lottery website ([www.lottery.ok.gov](http://www.lottery.ok.gov)), digital screens at retailers and outdoor boards throughout the state and can be used at authorized OLC retailers and on social media platforms. The winner hereby consents to the reasonable use by the OLC of the winner's photographs, voice, likeness, and/or image, contents of the entry form and the name and age of the winner without any further notice or compensation for any future promotional activity.
4. The OLC reserves the right, at its sole discretion, to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
5. Prizes pictured on point-of-sale materials and on the Lottery website/social media platforms are for illustrative purposes only.

6. Cash value cannot be substituted for prize.
7. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
8. The OLC and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The OLC is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the OLC and will not be returned. CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE OLC RESERVES THE RIGHT TO CANCEL THE PROMOTION IF IT BECOMES TECHNICALLY CORRUPTED.
9. The OLC reserves the right to refuse admission of an entry or group of entries if it is determined that the submission has occurred under a pretense that does not conform to the above listed rules.
10. Owners and employees of a licensed Oklahoma Lottery retail location may only win one promotional prize within a 12-month period unless specifically stated in the promotional procedures for a specific promotion. Promotional prizes include any cash or non-cash prize; methods of entry include but are not limited to social media, second chance, and Buy X Get Y, OK Lottery App promotions.
11. Former employees of the OLC are permitted to participate in promotions. If a former employee is selected as a winner of a promotion, they are required to speak with the security team prior to prize being awarded.
12. No other tickets or entries are eligible for this promotion, online games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
13. Ticket or terminal printed entries **must be submitted by the person or persons who purchased the ticket.** A qualified entry may be submitted by another individual if they have the expressed consent by the original purchaser of the ticket. Lottery retailers who purchase tickets within their store can participate in the promotion, however, entries or tickets left in the store by purchasing customers will not be eligible for the promotion.
14. The OLC will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
15. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
16. Each person entering this promotion agrees by the act of participation to be bound by these promotional procedures of the OLC.
17. Employees of the OLC and any family member living in their household are not eligible.

18. By participating in this promotion, entrants agree to release and hold harmless the OLC from and against any claim or cause of action arising out of participation in the promotion or receipt or use of any prize.
19. Winners may be required to take a picture and/or video to be used in advertisement on OLC assets. Failure to comply will result in forfeit of prize and an alternate winner will be chosen.
20. These promotional procedures may be modified at any time at the sole discretion of the OLC. Changes will be posted on our website.
