

## Promotional Procedures: “Test Your Luck”

### Promotion Type

Non-winning ticket 2<sup>nd</sup> chance drawing

### Promotion Detail

Purchase a \$1- *Test Your Luck* Scratcher and submit any non-winning *Test Your Luck* Scratchers as entries into the **Test Your Luck** promotion. Scratchers that award a “free ticket” as a prize are considered winning tickets and may not be entered into the promotion. Prizes for this promotion are listed below:

#### 1<sup>st</sup> Drawing- 9/17/15

Winner #1- **Lenovo- Yoga Tab 2- 10.1” Intel Atom- 16 GB valued at \$249.99**

Winner can choose to keep the Lenovo-Yoga Tab 2 or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the Lenovo- Yoga Tab 2 and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

**Winner # 2- Apple iPod Touch- 32 GB MP3 Player (6<sup>th</sup> generation) valued at \$249.99**

Winner can choose to keep the Apple iPod Touch or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the Apple iPod Touch and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

**2<sup>nd</sup> Drawing- 9/24/15**

**Winner # 3 – Apple iPad Mini-16GB valued at \$249.99**

Winner can choose to keep the Apple iPad Mini or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the Apple iPad Mini and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

**Winner # 4- Monster- 24K Over- the-ear headphones- gold/black valued at \$199.99**

Winner can choose to keep the Monster Headphones or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the Monster Headphones and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

**3<sup>rd</sup> Drawing- 10/01/15**

**Winner # 5- Vizio 32” smart TV valued at \$228.99**

Winner can choose to keep the Vizio 32” smart TV or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the Vizio 32” smart TV and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

**Winner # 6- HP- 14” Chromebook laptop valued at \$249.00**

Winner can choose to keep the HP 14” Chromebook Laptop or “Test Your Luck” and try for a cash prize of at least \$600. If the winner chooses to “Test Your Luck” they forfeit the HP- 14” Chromebook laptop and will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing.

\*If a winner is disqualified for any reason, their prize will be awarded to an alternate. The promotional procedures apply to both winners and alternates.

## **Potential 4<sup>th</sup> drawing- 10/6/15 (1 winner)**

### **“Test Your Luck” Cash prize**

A “Test Your Luck” cash prize drawing will only occur if any of the winners from drawings 1-3 choose to forfeit their prize in exchange for an entry into this drawing. The “Test Your Luck” cash prize will start at \$500 and will increase by \$100 for each prize forfeited in drawings 1-3. If a winner from drawings 1-3 chooses to forfeit their prize, they will receive a \$50 Best Buy gift card and an entry into the “Test Your Luck” cash prize drawing with the understanding that only 1 winner will be drawn and they could walk away only having won a \$50 Best Buy gift card.

- Fulfillment: Winner must complete the claims process and will then be awarded the prize at OLC.

### **Entry Submission Methods**

#### **Postal Mail**

An official entry consists of a non-winning *Test Your Luck* Scratcher from an eligible purchase completed and mailed to the Oklahoma Lottery headquarters. A complete name, address, telephone number, email (optional), signature and checked age verification box must be provided on the back of the ticket entry. Entries must be submitted in an envelope. Multiple entries in an envelope will be accepted. Each entry will be valid throughout the duration of the promotion. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail. Valid entries must be received at the Oklahoma Lottery headquarters by close of business on the final day of the entry period to be included in the selection process.

#### **Deposit at OLC Headquarters**

Players may enter the promotion by delivering entries to the Claims Department at the Oklahoma Lottery headquarters. Oklahoma Lottery employees cannot hand deliver entries from participating individuals, entries found to be delivered in this manner will be disqualified.

### **Entry Period**

Entries must be received prior to the final draw date of Oct. 1<sup>st</sup>, 2015 to be eligible for this promotional drawing. Each entry will be valid throughout the duration of the promotion. Valid entries must be received in the offices of the Oklahoma Lottery by the end of the day on the final day of the entry period to be included in the corresponding drawing.

## **Drawing Information**

The prize drawing will be held at the Oklahoma Lottery headquarters. During the drawing, only the drawing representative, security official and an accounting representative will be present. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer based automated drawing system will be used to execute the official drawing. For each drawing an equal number of entries will be drawn to serve as winners and alternates to cover the total number of winners needed for that entry period. The first half of the entries drawn will be assigned as winners and will be awarded prizes pending validation through the OLC claims process. The second half of the entries drawn will be assigned as alternates in case a winner or winners cannot claim their prize. Winners will be contacted by the Oklahoma Lottery for prize fulfillment purposes.

## **General Rules and Procedures**

1. Player's may only win one prize during this promotion.
2. All prize winners must be 18 years or older. Winners will be required to provide proof of age and may be required to show proof of purchase.
3. Winner(s) will be notified via phone/mail or email of their winning status using the contact information provided on the entry ticket. Final awarding of prize will take place after all validation processes have been completed.
4. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources. Winners' names and pictures will also be posted on the Oklahoma Lottery website ([www.lottery.ok.gov](http://www.lottery.ok.gov)) and can be used at authorized OLC retailers.
5. The Oklahoma Lottery, at its sole discretion, reserves the right to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
6. Prizes pictured on point-of-sale materials and on the Lottery website are for illustrative purposes only.
7. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
8. The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any

kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the Oklahoma Lottery and will not be returned. CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE OKLAHOMA LOTTERY RESERVES THE RIGHT TO CANCEL THE PROMOTION IF IT BECOMES TECHNICALLY CORRUPTED.

9. The Oklahoma Lottery reserves the right to refuse admission of an entry or group of entries if it is determined that the submission has occurred under a pretense that does not conform to the above listed rules.

Owners and employees of a licensed Oklahoma Lottery retail location may only win 1 promotional prize within a 12 month period unless specifically stated in the promotional procedures for a specific promotion. Promotional prizes include any cash or non-cash prize; methods of entry include but are not limited to Mobile Club, Facebook, second-chance, and Buy X Get Y promotions.
11. The Oklahoma Lottery, at its sole discretion, reserves the right to terminate any promotional drawing if the number of entries, for that promotion, does not exceed 100. The subsequent prize may then be offered in a future Oklahoma Lottery promotion.
12. No other tickets or entries are eligible for this promotion, including other Scratcher games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
13. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
14. The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
15. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
